Re: Report on Expenditure under the Policy on Support of Community Activities and Events

Commissioners:

The purpose of this letter is to report to the Commission on an expenditure made under the Policy on Support of Community Activities and Events.

The Kern Partnership for Children and Families have requested financial assistance to help offset the costs of supporting foster children ages 0 to 5 in the visitation, reunification and adoption process. More than 2,000 children in Kern County are in foster care. These are children removed from their birth families due to abuse or neglect and placed with other caregivers. Kern Partnership for Children and Families sees a widening gap between what children need and what government can provide and that is why the nonprofit was established.

The expenditure of \$1,000 was approved under the Commission's Policy on Support of Community Activities and Events. This policy provides, in part, that the Commission may provide funding to community partners to support activities, such as community awareness and education programs, and events that are in alignment with the Commission's Strategic Plan. The Commission may directly participate in such activities and events, but may also rely on contractors, grantees and other community partners to advocate for and promote community awareness of Commission issues, goals and funding opportunities. The policy also provides that the Executive Director may approve such expenditures and must then report the expenditure to the Commission.

IT IS RECOMMENDED that your Commission receive and file this letter.
